"As we enter 2023, the U.S. Patent and Trademark Office and the U.S. Copyright Office (the Offices) are conducting a joint study regarding the issues of intellectual property (IP) law and policy associated with non-fungible tokens (NFTs)," Fisher said. "The Offices are conducting virtual public

roundtables at the end of January 2023 to allow them to gather input to assist with the joint study. Among the topics for public comment include whether current IP laws are adequate to address the protection and enforcement of IP in the context of NFTs. The public is given the opportunity to provide input on any IP-related impacts in their respective fields or industries in connection with the uses of NFTs."

Fisher is a graduate of The American University Washington College of Law and Brandeis University.
